INTRODUCTION

- [1] The strategic objective for the development of higher education (HE) in Latvia is the establishment of a HE system based on cooperation among public, private and academic environment, in order to ensure the competitiveness of Latvia as a country, its national economy and higher education system in the common European space. The achievement of this objective requires internationalization of the HE system as a whole and each individual higher education institution (HEI).
- [2] The Internationalisation and Modernisation Strategy of the EKA University of Applied Sciences (EKA) 2024-2028 (in Latvian *Ekonomikas un kultūras augstskolas Internacionalizācijas un modernizācijas stratēģija 2024.-2028. gadam*, acronym- IMS2028) is a university-level medium term planning document, which has been developed within the framework of a higher level planning document *Development Strategy of the University of Economics and Culture* (in Latvian *Ekonomikas un kultūras augstskolas attīstības stratēģija 2024-2028*, acronym EKAAS).
- [3] EKA vision, defined in the EKAAS 2024-2028, is: "EKA inspires individuals to embrace change and innovation, by offering top-quality education and research, based on values of diversity and sustainable development." This, in turn, is aligned with objectives and planned activities within IMS2028.
- [4] Participation in Erasmus+ Programme is a crucially important prerequisite for successful implementation of IMS2028.
- [5] In achieving objectives of EKA-IMS2028, EKA undertakes to contribute to the goals of a European Education Area (EEA), and to perform in line with EU's renewed agenda for higher education. EEA focus topics are (<u>https://education.ec.europa.eu/focus-topics/eeain-the-world</u>):
 - Improving quality and equity in education and training
 - Developing of a high-performing European digital education ecosystem
 - Strengthening the sustainability competences of all learners.
 - Strengthening international cooperation with countries and regions around the world
- [6] An implementation plan is developed to monitor the progress in the achievement of IMS2028 goals.
- [7] The Vice Rector for Science and International Cooperation at EKA is responsible for the development of IMS2028 and its Implementation plan, as well as for monitoring the progress.

DEVELOPMENT PROCESS OF INTERNACIONALISATION AND MODERNISATION STRATEGY

IMS2028 was developed on the conceptual basis of the strategy for the previous period (Internationalization and Modernisation strategy of the EKA University of Applied Sciences 2021-2023 (IMS2023), following the EKA Erasmus+ Policy Statement (<u>https://www.augstskola.lv/?parent=686&lng=lva</u>), and taking into account recommendations from Accreditation Commission statements for the study directions of Economics, Management, and Law in 2021, IT and Arts in 2023 (Table 1).

On 13 February 2024, IMS2028 was discussed during the Administration meeting. EKA Rector, Vice-Rectors, Quality Manager, and programme directors analysed the strengths and weaknesses of EKA in the area of internationalization and modernization. Strengths and weaknesses were

analysed also at the meeting by EKA Erasmus+ Coordinator and representative of EKA Student Union. The results have been summarized in Table 2.

"Internationalisation can [...] offer students, staff and the organisation several benefits. It can advance strategic thinking leading to innovation, offer advantages in modernising pedagogy, encourage collaboration between students and staff, stimulate new approaches to learning, and new research collaborations." (HEInnovate, 2024)

Internationalisation is one of the priorities defined in EKA development strategy. The key objective is to enhance EKA international competitiveness by promoting students and academic staff mobility, strengthening international cooperation, involving foreign academic staff in the study process and supporting integration of international students into university life, thus contributing to the internationally recognized brand of the university and providing high quality multicultural learning environment.

The vision of EKA internationalisation: EKA is an internationally competitive and recognised, science-based and innovation-oriented higher education institution that:

- atttracts internationally recognised and qualified employees to perform scientific and academic activities;
- ensures multicultural environment to support students' and staff competitiveness both in the local and international labour markets;
- is a place for globally-known international research and academic events;
- actively cooperates with other universities, institutions and employers in Latvia and beyond in academic, research and creative activities.

EKA main goals stated in IMS2028 are:

- To support EKA staff and students' excellence by providing opportunities and motivating to participate in international mobility
- To establish the multicultural environment at EKA to ensure "internationalisation at home"
- To enhance the quality of the study process at EKA by attracting internationally recognised and qualified teachers to perform academic activities
- To support tolerance and diversity in the classroom by providing opportunities to develop intercultural and social communication skills among students and staff
- To raise awareness about environmental and climate-change challenges among students and staff and increase interest in social entrepreneurship in the field of circular economy and environment protection
- To promote civic engagement and active citizenship among students and staff
- To increase digital and research competences of EKA students and staff
- To promote the implementation of innovative teaching methods into the study process
- To increase the relevance of curricula by strengthening the cooperation with employers and providing problem-based learning and offering international mobility.
- To increase the number of programmes and study cources taught in English
- To increase international recognition of EKA and raise its reputational value in the academic and scientific environment

- To strengthen the existing and to expand the cooperation with other universities, institutions and employers in Europe, Asia, Africa, North and South America in the field of research and creative activities

The development and implementation of EKA IMS2028 is based on the future vision of education described in the *Education Development Guidelines 2021-2027* (project version <u>https://www.izm.gov.lv/sites/izm/files/iap2027</u> projekta versija apspriesana 160720201 2.p <u>df</u>). The Guidelines emphasize the necessity to strengthen lifelong learning opportunities and skills, specifically digital skills. Social skills (civic engagement, openness to different views and cultures, ability to change) are also treated as very important for the future.

The goals of the IMS2028 support the improvement of EKA staff and students' competencies. In defining the core competencies to focus on, EKA committed to the Council Recommendation on Key Competences for Lifelong Learning https://ec.europa.eu/education/education-in-the-eu/council-recommendation-on-key-competences-for-lifelong-learning_en

Thus, the goals of IMS2028 are printed towards improvement of Digital and technology-based competences (Pr3 GOAL 4), entrepreneurship competences (Pr4 GOAL 3), active citizenship (Pr3 GOAL 3).

The EKA University of Applied Sciences also focuses on the integration of the international dimension in the study process ("internationalization at home") in order to provide the opportunity for those who do not participate in international mobility to acquire skills that are required for the international environment and globalized world.
