INTRODUCTION

The development of science and research is a priority axis for the overall development of the country, governed by a number of strategic and normative documents at national level:

National Development Plan of Latvia for 2021-2027 (NDP 2027). NDP2027 is hierarchically the highest national medium-term development planning document. It also sets medium-term priorities in the field of education and science, highlighting the direction of action: Science for the development of society, the economy and security.

The Science, Technology Development and Innovation Guidelines 2021-2027 (STDIG2027). STDIG2027 contributes to the achievement of the strategic objectives set out in NAP 2027 in line with the goals and objectives of the directions "Science for the Development of Society, the Economic and Security" and "Quality, accessible and inclusive education" of the priority "Knowledge and Skills for Personal and National Growth".

The policy challenge of the STDIG is to develop a research and development (R&D) system that ensures a sustainable development of R&D human capital, knowledge, skills, competences and technologies, thereby contributing to the acquisition of quality education and skills, enhancement of social and economic welfare and security, improvement of the quality of life and transition to a climate-neutral economy.

Education Development Guidelines 2021-2027 (EDG 2027) are related to STDIG ZTAIP 2027 regarding activities to strengthen research-based higher education, to introduce research-based and innovation-oriented doctoral studies and promotion processes and the provision of opportunities for the development and growth of academic staff.

The Law on Scientific Activity (in force since 19.05.2005) stipulates that higher education institutions have the obligation to perform scientific activity and to provide a study process where the research activity and/or artistic creativity of students would be an integral part.

The scientific vision of the EKA University of Applied Sciences is defined in line with the overall vision of EKA development: "EKA is developing as an inter-branch multicultural university. It prepares knowledgeable, creative and independent personalities who are excellent professionals in their areas. EKA is associated with competitive education, internationally acknowledged diplomas, high professional quality of our graduates, well-developed scientific research base and highly qualified academic and administrative personnel."

The main objective of EKA **in the development of science and research** is to enhance the competitiveness of the university by building a strong base of scientific infrastructure and human resources, strengthening the cooperation between the science and business sectors, developing the transfer of research results to business, thus contributing to the achievement of the Latvian national strategic development goals.

Our success pillars are:

Interdisciplinary approach to study process implementation. EKA implements study programmes in different thematic groups which, in turn, promote a multidisciplinary approach to carrying out research and creative work:

1. Social sciences, commercial sciences - study directions "Economics", "Business management, administration and real estate management " (hereinafter referred to as "Management direction") and "Law";

- 2. Natural sciences, mathematics, information technology the study direction "Information technology, hardware, electronics, telecommunications, computer, and computer science " (hereinafter "IT direction")
- 3. The humanities and arts study direction "Arts".

Intercultural environment. In today's globalized world, successful business is based on cross-cultural literacy, which provides opportunities to navigate freely in the international market. By combining the economy and culture in its conception, by offering study programmes in different languages, by giving its students the opportunity to participate in seminars of foreign professors and master study courses abroad, by organizing international scientific and creative events, EKA is preparing business people for their work in the international business environment.

Creative and innovative approach to study. EKA provides both a face-to-face and distance learning process in the e-environment, offering e-studies where lectures, seminars and tutorials with teachers, as well as examinations take place in online virtual classrooms. EKA students are provided with the opportunity to acquire knowledge through the innovative infrastructure of EKA: simultaneous interpreting classroom, business simulations, DIG laboratory, court hall and artistic creation rooms.

THE PRIORITIES OF THE EKA UNIVERSITY IN SCIENCE AND RESEARCH

In order to achieve the scientific and research development objectives, a strategy for the development of science and creative activity (ZRDAS2023) of the EKA University was developed in 2021. ZRDAS2023 is a university-level medium-term planning document, developed within the framework of the "Development Strategy of the EKA University of Applied Sciences (Latvian abbreviation - EKAAS)".

ZRDAS2023 defines EKA's priorities in research and creative activities:

Priority "Quality assurance in research and creative activity" (Pr1)

Higher education institutions have the duty to perform scientific activity (Article 19(1) of the Law on Scientific Activity). For the purpose of carrying out the scientific activity, a higher school requires academic staff with scientific qualifications, which is evidenced both by a doctor's degree and an expert status of the Latvian Scientific Council, as well as high quality scientific publications. The evaluation of the quality of research and creative activity is also based on the achievements of the academic staff and students, as well as on the achievements of EKA in project implementation and funding attraction.

Priority "Involvement of academic staff in research and creative activity in each study direction" (Pr2)

One of the criteria for assessing a study direction is "The involvement of academic staff in scientific research and/or artistic creation". In order to achieve results in this area, EKA is planning to introduce new practices for establishing international research teams. In addition, it is envisaged to set up an academic staff assessment system, where the research and creative activity criteria will play an important role. as well as a corresponding financial motivation system.

Priority "Involvement of students in research and creative activity in each study direction" (Pr3)

"Student involvement in scientific research" is an important criterion in the assessment of study directions.

The EKA University of Applied Sciences implements study programmes in five study directions:

- 1. Economics
- 2. Business management, administration and real estate management (hereinafter referred to as "Management")
- 3. Information technology, computer engineering, electronics, telecommunications, computer management and computer science (hereinafter referred to as "IT")
- 4. Law (hereinafter referred to as "Law")
- 5. Arts

EKA's priority in the study process is research-based studies, which include the integration of the "students as researchers" approach in study programmes at all levels. "Students as researchers in the context of higher education mean a pedagogical approach aimed at supporting students to engage in order to complement their knowledge and enhance their skills." (Walkington, The Higher Education Academy, 2015)

Priority "Cooperation in research and creative activity" (Pr4)

In defining the objectives for promoting cooperation in research and creative activity, cooperation is addressed from various viewpoints:

- institutional cooperation cooperation between EKA academic staff
- national cooperation cooperation of EKA academic staff with academic staff of other Latvian higher education institutions
- international cooperation cooperation of EKA academic staff with academic staff of foreign universities
- EKA cooperation with the business sector (academic-corporate collaboration)

Priority "EKA reputation" (Pr5)

The scientific reputation is a prerequisite for the improvement of the overall image of the university in the academic environment, which, in its turn, promotes the visibility of the university among students, facilitates cooperation with other universities and institutions, provides for the loyalty of academic staff.

Pr1 PRIORITY "QUALITY ASSURANCE IN RESEARCH AND CREATIVE ACTIVITY"

In 2022/2023, the academic staff of EKA consisted of more than 100 people, 44 of whom were elected to the academic posts of EKA (as of 30.06.2023, incl. 25 persons (56%) with a doctor's degree.

2.1. Priority research directions and research teams

One of the criteria for assessing a study direction is "The involvement of academic staff in scientific research and/or artistic creation". In order to achieve results in this area, EKA has introduced new practices – formation of international research teams. Teams are formed in priority research directions approved by the relevant Study Direction Council (Table 3). Each research direction has a coordinator responsible for achieving the expected results. In 2022/2023, teams were created in four directions (Table 4).

Pr3 PRIORITY "INVOLVEMENT OF STUDENTS IN RESEARCH AND CREATIVE ACTIVITY IN EACH STUDY DIRECTION"

EKA's priority in the study process is research-based studies, which include the integration of the "students as researchers" approach in study programmes at all levels. "Students as researchers in the context of higher education mean a pedagogical approach aimed at supporting students to engage in order to complement their knowledge and enhance their skills." (Walkington, The Higher Education Academy, 2015)

Each EKA study programme includes a study course on research methodology: bachelor programmes – "Research Organization" and Master programmes – "Research organization and academic work". In addition, a number of other courses have an integrated research component, such as the study course "Sociology", "Strategic and change management", "Environmental policy", etc.

According to Article 3.2.16. of the "GUIDELINES ON PREPARATION AND DEFENSE OF STUDY PAPERS, PROJECT PAPERS AND THESES AT THE EKA UNIVERSITY OF APPLIED SCIENCES": "the master's degree students shall be admitted to the defense of thesis, if they had previously submitted an article to the Student Scientific and Applied Conference".

Every year, EKA hosts a Student Conference with students from all EKA study directions, students from Alberta College and other higher education institutions. In 2022/2023, EKA students submitted 134 research abstracts, as well as 18 descriptions of creative and artistic works. In addition, EKA students submitted 89 full text articles to the EKA/AK Student research paper collection.

In 2022/2023, EKA students also participated in other scientific and creative activities. For instance, in 2022/2023, EKA students participated in the MAKE-IT project "Innovation grants for students in the fields of art, culture, economics and IT interdisciplinary areas" (No .1.1.3/21/A/003) and developed creative ideas:

- Team "Pelni pelna" students from the programme "Circular Economy and Social Entrepreneurship". Outcome: the use of wood chips as a concrete mass filler (partially replacing cement), in order to then use this mass in the production of rails, which would ensure the accessibility for persons with impaired vision, reduced mobility and behavioural disorders;
- Team "Europa School Mobile" students from IT study programme. Outcome: a
 modernized information system for European Distance Education High School (one of the
 components of the system is mobile application for pupils, parents and staff);
- Team "Market Map" students from the study programmes "Marketing" un "Information technologies". Outcome: positioning of the "Draugiem group" brand "Pērkam Kopā" (let's buy together) or developing a prototype of a business model to create a different brand from

existing and competing positions in the market, thus taking a niche that cannot be repeated quickly by competitors;

- Team "ChameleOn" students from the study programme "Marketing". Outcome: *layout* services for printed materials adapted to the client's business needs and development of a visual merchandising strategy to implement business goals, increase its visibility and promote profit;
- Team "Feelful" students from the programme "Culture management". Outcome: a set encouraging self-expression and self-awareness;
- Team "Icey and Melty" students from the programme "Culture management". Outcome: ice cream, which contains the necessary daily dose of vitamins for a person, enriching the diet of people with the necessary vitamins in a light and effective manner;
- Team "Ratiņš labs" students from the programme "Culture management". Outcome: *baby strollers made of recycled and sustainable materials*;
- Team "Healthy Algorithm" students from IT study programme. Outcome: a product that
 will ensure the specific needs of medical institutions and ease the workload of staff, as well as
 make the registration for visits more convenient and effective.

The works of Annija Norde and Eva Ralle, students of the study programme "Interior Design", were nominated for the 2nd round of the competition "Dizaina arēna 2022" organized by the Latvian Designers' Society, in the category "Environmental Design", in Ķīpsala. Annija was awarded the Latvian Designers' Society diploma for 3rd place in the category "Environmental Design", as well as a diploma for 3rd place in the category "Design Research".

The students of the study programme "interior design" participated in the International Environmental Art Project "Initium Vilnensis" organized by the Vilnius College of Technology and Design (Vilniaus technologijų ir dizaino kolegija - VTDK). "Initium Vilnensis" demonstrates the practice of sustainable and conscientious art, therefore students created their own works of art in the style of "Land Art", highlighting the synergy between the human touch and the eternal power of nature.

Within the framework of the course "Production" (study programme "Culture Management"), the closing event of the Happiness season II was organised, as well as the project *Kultūras Kulenis*, was created, which consisted of several events and took place in Sigulda's Devons.

The students of the study programme "Culture Management" with their lecturers E.Čerkovskis and B. Guste (team "Vērdiņš") took the 10th place in the Latvian national mind games of financial literacy among 78 teams.

Pr4 PRIORITY "COOPERATION IN RESEARCH AND CREATIVE ACTIVITY"

In defining the objectives for promoting cooperation in research and creative activity, cooperation is addressed from various viewpoints:

- institutional cooperation: cooperation between EKA academic staff in research and creative activities
- national cooperation: cooperation of EKA academic staff with academic staff of other Latvian higher education institutions
- international cooperation: cooperation of EKA academic staff with academic staff of foreign universities
- EKA cooperation with businesses and public sector

4.1. Institutional cooperation

Cooperation of EKA academic staff is carried out mainly through participation in research teams and joint research activities, the results of which are reflected in scientific papers. 25% of the prepared papers in 2022/2023 are joint papers of EKA academic staff.

EKA academic staff members also jointly participate in professional development activities – such as a Methodological conference (see section 5.1 of the Report) or in scientific seminars and workshops, for example, workshop "Research Methods for Data Processing: The Use of VOSviewer and STATA" 19.06.2023 (lecturers: Dr. Oleksii V. Lyulyov and Dr. Tetyana Pimonenko, Sumy State University, Ukraine) or "AI in study process and research" 19.04.2023. (lecturer: Dr.K.Šteinbergs, EKA)

EKA staff representatives actively engaged in research and became members of the EKA Science Club. It was established in 2020 with the aim of contributing to the development of EKA research, to develop priority research directions of EKA and to raise awareness of scientific events organized by EKA.

4.2. National cooperation

Cooperation within the MAKE-IT project

On 17 November 2021, EKA and the Central Finance and Contracting Agency (CFCA) signed an agreement on the implementation of the ERDF project 'Innovation grants for students in the fields of arts, culture, economic and IT interdisciplinary areas (MaKE IT)', No 1.1.1.3/21/A/003.

The aim of the project is to increase the entrepreneurial capacity of students by promoting cooperation between universities, students and businesses.

Students at all levels and of all programs, as well as students of senior years from professional secondary and general secondary schools are the main target group. The project target group participants will have access to grants and other support for the implementation of their own or team's innovative ideas.

The project lasts till November 2023 and is implemented in cooperation with partners: "Foundation of the EKA University of Applied Sciences", BA School of Business and Finance, Ventspils High Technology Park Foundation, Limited Liability Company "ALBERTA

KOLEDŽA", Limited Liability Company "Institute of Economics of the Latvian Academy of Sciences", LLC "EUROLCDS".

Jevgenija acted as a mentor and a facilitator for EQUALS-EU project participants – active women from many countries, such as Greece, Croatia, Indonesia, Nigeria and others. The summer school programme focuses on women's professional development as future leaders and champions in gender equity and digital inclusion and promotes knowledge exchange and technology transfer within European countries and between European and non-European countries.

The EKA University of Applied Sciences as one of only few Latvian universities has been approved as a partner in an ambitious EU project within the framework of the European Institute of Innovation and Technology (EIT) initiative for Higher Education Institutions (HEI) - "Building Forward Better"




ecosystems - Harnessing the power of networked communities to scale-up and accelerate the impact of entrepreneurial universities – Network IQ Alliance". Network IQ Alliance is a community of entrepreneurial universities from Spain, Poland, Latvia, Ireland and the UK, an innovative SME, a network of research institutes, an industry network, and a global network of science and technology parks in 77 countries.

The goal of NIQ project is to empower purpose-driven entrepreneurial people to amplify growth opportunities from the networks they build to innovate better, faster and have long-

term resilience. To achieve this, the Network IQ Alliance consortium is committed to mainstream network intelligence (nIQ) – a system-change methodology developing digital competencies at the ecosystem level for innovation and networking.

In 2023, EKA representatives participated in the activities within WP3 "Train-the-Trainer and Learning Excellence Hubs". From the EKA University of Applied Sciences, the Rector, Dr. oec. Oksana Lentjusenkova, Vice-Rector for Science, Dr. oec. Jelena Titko, Associate Professor, Dr. psyh. Kristine Uzule, Assistant Professor, Dr. oec. Kaspars Steinbergs, and Head of the Development of the Scientific Institution, Dr. oec. Jevgenija Dehtjare, participated in this training. During the training, the participants learned the concept of Network Intelligence, which was authored by Dr. Daria Tataj, Honorary Professor, Massoud Center for Entrepreneurship, University of Manchester. The training program included topics on network theory, network development, networking, Network IQTM skills, and using LinkedIn. In addition, on June 29 and 30, EKA representatives also attended the master class led by Dr. Daria Tataj. It should be noted that the Rector of the EKA University of Applied Sciences, O. Lentjusenkova, is also a member of the Train-the-Trainer Standardization Working Group, whose purpose is to develop a Network IQTM methodology manual for higher education institutions.

On June 29, a meeting of project partners was held in Barcelona at La Salle Ramon Llull University, where the actualities of project implementation were discussed. Kaspars Steinbergs, project manager of the Scientific Institution, represented EKA. This university was chosen as the meeting place not only because it is the leading partner of the project but also because it hosted the XXI Triple Helix conference "Entrepreneurial and Engaged Universities for Sustainable Development." K. Steinbergs also participated in this conference with the report "Industry-University Cooperation: A Case Study in Latvia".

- create online scalable model of ICT-based entrepreneurship hard and soft skills development module that can be implemented in partner countries;
- enhance ICT competence by wide involvement of engineering and technology students in learning-by-doing IT-practices including block chain, internet of things, automation etc.;
- elaborate guidelines for recognition of joint ICT-based entrepreneurial module within ECTS credit system in partner countries;
- implement ICT-based entrepreneurial module in ICT university curricula in partner universities.

The aim of the VILESA project is to solve the problems of application of modern teaching/learning methods in social sciences by digitizing the study content by using a Virtual reality platform. The application of modern technologies to the digitization of study content encourages creativity and creates opportunities for users to get involved in the content creation process themselves. Encouraging creativity, adapting content to the younger generation of learners (Generation Z) is based on developing practical skills while reducing environmental impact and contributing to business sustainability. The project is intended to reinforce and sustain such positive behavioural trends.

In the first stage of the project, the representatives of the partner universities worked intensively on the development of the "case study" concept and description - each in their own direction (economics, marketing, management and insurance).

EKA project participants - lecturers Jeļena Budanceva (director of the programs "Cultural management" and "Management of international cultural projects") and Edgars Čerkovskis (director of the program "Circular economy and social entrepreneurship") - developed the descriptions "Cultural Project management" and "Circular economy: natural resources".

The BENEFIT project's main objective is expanding the quality and efficiency of education provided by HEIs, by further building on the Erasmus+ project "EMBED - European Maturity Model for Blended Education". Such activities set the foundation for inclusive blended learning and teaching methods as modernized and dynamic models for the HEIs. By doing

so, HEIs are adequately transforming to the needs of modern era, by promoting better student experiences, greater personalisation and significantly higher efficiency. Furthermore, the need for implementation of the blended learning concept is also noted by the European Commission through the "Digital Educational Plan 2021-2027" as its potential benefit are immense.

In 2023, European Analysis of Inclusive Education has been completed. During this stage, the participants of the project from Latvia, North Macedonia, Croatia, Bulgaria and Greece analysed the current state of inclusive education in their respective nations. The EKA University of Applied Sciences reviewed the Latvian national legislation, policies, and practices on inclusive education, focusing on higher education and interests of people with special needs. As a result of the analysis, it was concluded that the national legislation and policies of the Republic of Latvia include basic provisions for the implementation of inclusive education and Latvian higher education institutions have been taking steps to deliver inclusive education opportunities, for example, via digital technologies and the enhancement of the physical environment.







Cooperation with individual foreign researchers

19.06.2023. The EKA University hosted "Virtual Research Festival". This event was implemented remotely by the Ukrainian Sumy State University with the support of the EKA Scientific Institution. The aim of the festival was to introduce the academic staff of the EKA University and the researchers of the EKA Scientific institution with modern research methods. 4.4. EKA cooperation with business and public sector

5.2. EKA publishing activities

Since 2015, EKA in cooperation with Alberta College, has been issuing a collection of scientific articles "Collection of student scientific research papers". The collection of scientific research papers includes papers of the students of the EKA University of Applied Sciences (EKA), Alberta College (AK) and other HEIs submitted to the International Student Scientific and Practical Conference. The articles reflect the results of the research carried out in the fields of economics, finance, accounting, management, public relations, marketing, information and communication technologies, law, etc. fields.
